

VA / FHA LOAN ADDENDUM

4 This VA / FHA Loan Addendum is made a part of the *Purchase and Sale Agreement* for the Property
5 identified above. Should any terms of this Addendum conflict with the terms of the *Purchase and Sale*
6 *Agreement*, the terms of this Addendum will control.

7 **AMENDATORY CLAUSE:** "An amendatory clause must be included in the sales contract when the borrower
8 has not been informed of the appraised value... The amendatory clause must contain the following language:"

9 "It is expressly agreed that notwithstanding any other provisions of this contract, the purchaser shall not be
10 obligated to complete the purchase of the property described herein or to incur any penalty by forfeiture of earnest
11 money deposits or otherwise unless the purchaser has been given in accordance with HUD/FHA or VA requirements
12 a written statement by the Federal Housing Commissioner, Department of Veterans Affairs, or a Direct Endorsement
13 lender setting forth the **appraised value** of the property of not less than \$_____ [insert the sales price
14 as stated in the contract]. The purchaser shall have the privilege and option of proceeding with consummation of
15 the contract without regard to the amount of the appraised valuation. The appraised valuation is arrived at to
16 determine the maximum mortgage the Department of Housing and Urban Development will insure. HUD does not
17 warrant the value or the condition of the property. The purchaser should satisfy himself/herself that the price and
18 condition of the property are acceptable." (HUD Handbook 4155.1 Chapter 3-4)

19 **INSPECTIONS, REPAIRS, AND CONDITION OF PROPERTY:** VA and FHA do not guarantee the
20 value or condition of a home, or that it is free of defects. VA and FHA appraisals are not intended to be
21 "home inspections." VA and FHA appraisals, seller's property condition disclosures, and Home Protection
22 Plans are not substitutes for a professional home inspection. Well, septic, wood destroying insect and other
23 inspections or certifications may be required. The lender may also require that certain repairs or treatments
24 be completed, or that the property be connected to public water or sewer if available and feasible. **The costs**
25 **of any such inspections, certifications, treatments, connections or repairs should be negotiated in the**
26 ***Purchase and Sale Agreement.***

27 **For your protection, get a home inspection by a qualified home inspector licensed in Tennessee.**

28 **CLOSING COSTS AND NON-ALLOWABLE SETTLEMENT CHARGES:** Government guidelines do
29 not allow certain charges to be paid by the buyer. These "non-allowable" charges must be paid by the seller
30 or the lender. **Any seller contributions to the buyer's closing costs (including the VA Funding Fee)**
31 **must be addressed in the *Purchase and Sale Agreement*, and any non-allowable charges will be**
32 **included in the total amount of any seller contributions negotiated.**

33 **REAL ESTATE CERTIFICATION:** "The borrower, seller, and the selling real estate agent or broker
34 involved in the sales transaction... certify that the terms and conditions of the sales contract are true to the best
35 of their knowledge and belief and that any other agreement entered into by any of the parties in connection
36 with the real estate transaction is part of, or attached to, the sales agreement." (HUD Handbook 4155.1, 3-3)
